Specific Copyright Issues to be Considered

- Works published before 1923 are in the public domain and can be reproduced. These include, but are not limited to, photographs, books, maps, posters, graphics, and postcards.
- Works published after 1923 may still be under copyright. Some examples include:
 - Photos that are either marked as made by or appear to have been made by:
 - wire services (example: Associated Press)
 - movie and recording studios (example: publicity stills)
 - commercial photographers (example: family portraits)
 - Postcards
 - Architectural drawings
- Archives often contain materials that are unpublished. The following is excerpted from the Society of American Archivists' [Copyright and Unpublished Material: An Introduction for Users of Archives and Manuscript Collections](#):
 - Generally, material is considered unpublished if it was not intended for public distribution or if only a few copies were created and distribution was limited.
 - Copyright in an unpublished work lasts for the life of the author plus 70 years. If the author (or the author's death date) is unknown or if the author is a corporate body, then the term is 120 years from the creation date for the work. Therefore much unpublished material in archives or manuscript collections is likely to still be under copyright.
